



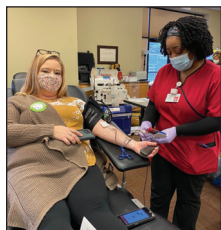
SkyLine/SkyBest & NC Broadband Co-ops Partner with UNC Health Foundation to Support Rural Children's Health Programs

SkyLine/SkyBest, a member of CarolinaLink, the North Carolina's Broadband Cooperative Coalition, announced a \$500,000 commitment and 10-year partnership with UNC Children's Hospital to support rural virtual health programs across the state. The gift from CarolinaLink will allow UNC Children's to develop a telemedicine program that will connect children in rural areas across North Carolina with specialty providers at UNC Children's Hospital in Chapel Hill.

SkyLine CEO Kim Shepherd commented on the gift stating, "We are proud to be partnering with our CarolinaLink members to make this gift to UNC Children's Hospital. North Carolina's communications cooperatives have always worked to serve the underserved areas of our state by providing critical communications services. This new telehealth program is a perfect opportunity to utilize the broadband services we provide to connect families living in rural areas to world-class health services from UNC Children's Hospital."

UNC Children's Hospital has begun forging partnerships with other health systems and pediatric offices in communities across the state to launch the telehealth programs. Locations will be selected in areas where it is more difficult to travel to the Triangle for pediatric specialty services.

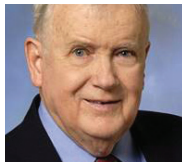

New Scholarship for First-Year Law School Students Established

The Foundation for Rural Service has announced a new scholarship for students with an interest in rural communities entering their first year of law school. The scholarship honors James L. Bass and the first scholarship of at least \$5,000 will be awarded this spring.

With an active law career that spanned more than 70 years, James Bass helped secure funds for rural telephone systems to bring modern telephone service to rural areas. He was pivotal in the creation of NTCA, where he served as one of the organization's earliest presidents. Bass continued his leadership with service for more than 50 years as legal counsel. Recognizing Bass's impact to the industry and his passion for the legal profession, the NTCA Board of Directors established a scholarship for students with an interest in rural communities to attend law school.

"Jim was not only a founding member of NTCA, he was a guiding light for our association through much of his lifetime," said Shirley Bloomfield, chief executive officer of NTCA. "He spent his last years in service to the association as our general counsel where he helped guide our national board through growth and transformation."

"Once again, FRS, as the advocacy arm of NTCA – The Rural Broadband Association, has introduced a program that invests in our young people and in the future of rural communities," said SkyLine CEO Kim Shepherd. "We are delighted to partner with the FRS in promoting this new scholarship program for our region and hope several will apply." The deadline to be considered for the spring 2021 James L. How Can I Protect Myself from Caller ID Spoofing?

Caller ID Spoofing occurs when a caller intentionally disguises his or her identity by altering their name and/or phone number that is displayed on your telephone.

One tactic commonly used by scammers, called Robocallers, is neighbor spoofing. Robocallers will alter their number to appear as a local number that could be similar to your own, to increase the likelihood that you will answer the phone call. Unfortunately, these scam artists have the ability to frequently change the number transmitted to your caller ID to any number of their choosing at any time. Any telephone number is at risk of being used by Robocallers.

To minimize your risk of falling victim to spoofing scams, pay attention to the incoming calls you accept. Do not answer any calls from unfamiliar numbers. Do not provide any information or follow any instructions if prompted by an unknown caller.

SkyLine/SkyBest provides multiple features that may help reduce the threat of Robocallers connecting to your home telephone line.

Anonymous Call Rejection allows you to block any caller who is blocking their name and number. Unknown callers who are attempting to call your home phone will receive a message that you do not accept blocked calls, and will advise them to unblock their number before trying again. Any calls that are not blocked will come through normally.

Selective Call Rejection allows you to block a list of specific telephone numbers of your choosing. Up to 16 numbers can be blocked at a time. You have the option to easily add or remove numbers from your rejection list directly from your home phone.

Smart Call Manager provides many comprehensive call screening options. Telemarketer screening will screen all long distance calls and prompt the caller to press "1" to connect. Telemarketing calls will be unable to connect to your home phone. If you receive calls frequently from specific long distance numbers, you may add them directly to your known callers list to prevent them from hearing the telemarketer announcement. This feature also includes Selective Call Rejection that will allow you to block up to thirty specific numbers from connecting with you. Call us at 1-800-759-2226 to learn more.
