Improvements to this area of the library were not included during the expansion of the library in 2009. Cosmetic and functional improvements are planned including the revamping of the technology set-up in the room and the addition of a mural that will follow the history of the library from its humble beginnings in the Old Hotel to the present and future outreach to the community.

FRS Scholarship Program Continues Online Application in 2022



If you have a son or daughter graduating from high school this spring, he or she may be eligible for the Foundation for Rural Service (FRS) Scholarship sponsored locally by SkyLine Membership Corporation.

In 2022, the FRS will award one-year scholarships in each geographic region of the NTCA membership (including the service area of SkyLine/SkyBest) to graduating high school seniors whose families are served by NTCA member organizations. For each FRS general scholarship, FRS provides \$2,000 and the sponsoring NTCA member company provides \$500. According to the FRS, more than two-thirds of rural Americans with postsecondary degrees never return to their rural communities, so this program gives particular emphasis to those students who plan to return to their community following college. Eligibility requirements include the following:

- Applicants must be children of SkyLine members or SkyBest customers who subscribe to either company's facilities-based services.
- Applicants must be graduating high school seniors and reside full-time with their parent(s) in the companies' service area.
- Applicants must have at least a C grade-pointaverage (GPA). FRS scholarships will be awarded to deserving students whose academic credentials fall within an average to above-average range.
- Applicants must be accepted to an accredited twoor four-year college, university or vocational-technical school.
- Applicants must express an interest to return to a rural community following graduation.
- Applications must be sponsored by SkyLine, an NTCA-member company.

Note: Children of SkyLine employees or directors are not eligible for this scholarship.

The Foundation for Rural Service (FRS), in cooperation with NTCA – The Rural Broadband Association, seeks to sustain and enhance the quality of life in America by advancing an understanding of rural issues. Through its various programs and initiatives, FRS strongly supports the continuing education of rural youth. Recipe of the Month

Apple Crunch

Ingredients:

6 large apples, peeled, cored, and thinly sliced 1/2 cup granulated sugar 1/2 teaspoon cinnamon or nutmeg

Topping:

1 cup all-purpose flour 1 cup brown sugar 1/2 cup butter

Instructions:

Pre-heat oven to 325 degrees. Grease an 8-inch square pan. Spread apples in pan. Top with granulated sugar and sprinkle with cinnamon or nutmeg. Mix together flour and brown sugar. Cut in butter using pastry cutter or your fingers until mixture resembles coarse meal. Spread over apples. Bake 1 hour. This is best served with ice cream or whipped cream. NOTE: I put 1 teaspoon cinnamon and 1/2 teaspoon nutmeg in mine.
