FRS Scholarship Program **Applications Available This Month**



If you have a son or daughter graduating from high school this spring, he or she may be eligible for the Foundation for Rural Service (FRS) Scholarship sponsored locally by SkyLine Membership Corporation.

This year, 30 one-time, \$2,500 scholarships will be awarded to rural high school seniors: one per geographic region of the National Telecommunications Cooperative Association (NTCA) membership and one to a student sponsored by a NTCA associate member. The remaining 19 awards will be distributed proportionate to the number of applications received per region. FRS will fund \$2,000 of each scholarship, with the sponsoring cooperative of each winning student providing a \$500 match. Additional scholarships also will be awarded, including four \$5,000 FRS Staurulakis Family Scholarships, with preference given to students who are majoring in math, science, engineering or medicine fields.

Eligibility requirements include the following:

- Applicants must be children of SkyLine members or SkyBest customers who subscribe to either company's telephone services.
- Applicants must be graduating high school seniors and reside full-time with their parent(s) in the companies' telephone service area.
- Applicants must have at least a C grade-point-average (GPA). FRS scholarships will be awarded to deserving students whose academic credentials fall within an average to above-average range.
- Applicants must be accepted to an accredited two- or four-year college, university or vocational-technical school.
- Applicants must express an interest to return to a rural community following graduation.
- Applications must be sponsored by SkyLine, an NTCA-member company.

Application packets will be available beginning Friday, January 6, at area high school guidance departments, Sky-Line Customer Centers and our website: www.skybest.com. The application deadline is February 13.

Note: Children of SkyLine employees or directors are not eligible for this scholarship.

Recipe of the Month

Cheesy Potato Soup

Ingredients:

5 large potatoes, peeled and diced Water

1 tsp. salt or to taste

½ stick butter

6 Tablespoons flour

½ cup evaporated milk ½ (15-oz.) can Tostitos salsa cheese dip

Approximately ½ cup milk

Bacon, crumbled (optional)

Instructions:

Place potatoes and salt in a large pot and cover with water. Cook until done, then add butter. In a separate bowl, mix evaporated milk into flour gradually to form a smooth paste. With potatoes on low, pour flour mixture in and stir to make a thick broth. If broth becomes too thick, add milk to meet desired consistency. Then, add cheese dip.
