# SkyLine Issues \$900,000 in Capital Credit Refunds

This year, SkyLine Membership Corporation is issuing approximately \$900,000 in capital credit refund checks to active and inactive members of the cooperative who had service in 1996.

Capital credits represent each member's ownership of this cooperative and come from the margins allocated to our members' capital credit accounts based on their use of SkyLine's services. As a not-for-profit business, SkyLine assigns any monies remaining after expenses to the capital credit accounts of its members. Allocated capital credits are used over time as working capital for SkyLine to invest in the latest technology and maintain a robust telecom infrastructure to meet the technology needs of its members. Active members who had service during these years and have not received a refund check by early October should call their local SkyLine Customer Center at 1-800-759-2226.

Along with assigning an annual allocation to members' capital credit accounts, our Board of Directors determines if a retirement (refund) is in order based on the cooperative's sound financial condition. The 2022 general retirement is based on a percentage of current and former members' allocation, specifically 35 percent of the unretired balance for 1996. The refund is distributed to active and inactive SkyLine members who had service during those years.

SkyLine will issue refunds through a bill credit to active members if their individual refund falls below a designated dollar value threshold. We plan to continue regular refunds, so please advise us of any change of address.

# **October is National Co-op Month**

Celebrated by more than 40,000 cooperatives nationwide during the month of October, National Co-op Month is an annual opportunity to raise awareness of a trusted, proven way to do business and build communities. Under the theme "Co-ops Build Economic Power," this year's Co-op Month is also a chance to lift up the cooperative business model as the best way to build an economy that empowers everyone.

Recognizing the important role that cooperatives like SkyLine play as a rural telecom leader, contributor to the regional economy and the investments they make to strengthen rural communities, this year's theme closely aligns with the work SkyLine does. Having achieved a Fiber-to-the-Premse (FTTP) deployment across the coop's service area in 2016, SkyLine continues to expand fiber connectivity to unserved and underserved areas through SkyBest, its wholly-owned subsidiary. This advanced infrastructure was critical not only during a pandemic where virtual access was essential for business, education and healthcare, but it's also making a generational impact, ensuring greater prosperity for rural areas well into the future.

## State of Tennessee Names SkyBest and Loretto Among 36 Grantees to Receive Significant Grants for Broadband Expansion

SkyLine's two subsidiary companies – SkyBest Communications, Inc. and Loretto Telecom – were recently named recipients of \$13.09 million in total grant awards through the Tennessee Emergency Broadband Fund – American Rescue Plan for fiber deployment projects in Johnson, Carter and Lawrence counties. With matching funds provided by SkyBest and Loretto, the \$18 million project will include 356 miles of fiber construction with the potential to serve more than 4,050 homes and businesses.

Tennessee Governor Bill Lee and Tennessee Department of Economic and Community Development (TNECD) Commissioner Stuart McWhorter announced on September 12 that the state will award \$446,770,282 in grants for the expansion of internet access across the state of Tennessee.

In total, the broadband infrastructure grants will provide broadband access to more than 150,000 unserved homes and businesses across 58 counties.

"People are moving to Tennessee from across the nation in record numbers, and we have an obligation to prepare our state for continued growth," said Governor Bill Lee. "Our strategic investments in broadband infrastructure will ensure our rural communities are connected and have every opportunity to thrive, and I thank the Financial Stimulus Accountability Group for managing dollars effectively to serve Tennesseans."

According to the 2020 Broadband Deployment Report published by the Federal Communications Commission (FCC), one in six rural Tennesseans lacks access to broadband. Since 2018, TNECD has awarded nearly \$120 million in broadband grants through state and federal funding to serve more than 140,000 Tennessee households.

"To achieve economic growth and prosperity, it's imperative that Tennessee's communities have the proper infrastructure in place," McWhorter said. "Thanks to the \$447 million awarded in funding, broadband access will be available to 36 grantees with 75 projects across 58 Tennessee counties, and we look forward to seeing how these grants spur further success among each community."

These grantees are a range of internet service providers, including electrical and telephone cooperatives, local municipalities, private providers and cable companies. These grant recipients were chosen through a rigorous criterion, which included the need of the grant area, the ability to complete the project and strong community support.

"We are absolutely delighted to be named a grant recipient by the State of Tennessee to bring essential fiber connectivity to our neighbors in east and middle Tennessee through this funding initiative," said SkyLine Chief Executive Officer Kim Shepherd. "Reaching our fiber deployment goal early across SkyLine's service area positioned us to turn to those unserved and underserved communities nearby, and this significant funding will accelerate our efforts to get these communities connected and further bridge the digital divide that still exists in many communities."

The grant funds earmarked for Johnson and Carter counties in east Tennessee total \$5.69 million with a total project cost of \$8.5 million with matching funds provided by SkyBest. This project will encompass 256 miles of fiber construction with a potential to serve more than 2,250 homes and businesses.

#### What are Cooperatives?

Cooperatives are owned and governed by their members – the same people who use the co-op's goods or services. ## Recipe of the Month Apple Crunch

#### Ingredients:

- 6 large apples, peeled, cored and thinly sliced
- 1/2 cup granulated sugar
- 1/2 teaspoon cinnamon or nutmeg
- 1 cup all-purpose flour
- 1 cup brown sugar
  - 1/2 cup butter

### Instructions:

Pre-heat oven to 325°. Grease an eight-inch square pan. Spread apples in pan. Top with granulated sugar and sprinkle with cinnamon or nutmeg. Mix together flour and brown sugar. Cut in butter using pastry cutter or your fingers until mixture resembles coarse meal. Spread over apples. Bake 1 hour; best served with ice cream or whipped cream.

*NOTE:* I put 1 teaspoon cinnamon and 1/2 teaspoon nutmeg in mine.
